| <p>CHIP 2013-2018 Overview Presentation</p> | <p>Charlotte (FL Health in Miami Dade County) gave a presentation today on the Community Health Improvement Plan (CHIP) to address all items in the State Health Improvement Plan. This is a review of the ongoing efforts. A matrix was created to tie all the objectives of the State Health Improvement Plan on how we can implement the activities that support those objectives here locally in Miami Dade. This presentation was also presented at the Executive Board meeting on July 15, 2013. A handout of recommended Children Issues Committee objectives was also given to the committee as a sample.</p> <p>One of the recommended Children Issues committee objectives discussed was Objective HP4.1.2, the developing and implementing of a statewide early childhood safety and drowning prevention campaign. Joanne, UM, mentioned parenting classes for water safety are offered at the University of Miami. Dr. Ruby Natale, UM, mentioned the University of Miami has a safety prevention program called Injury Free Mobile. This is a water mobile van that looks like a house and goes into the community- you can view all the safety issues in this van. For example, viewing a kitchen to see all of the safety issues. They also have an assimilation of a pool and the safety measures behind it. This is known as one of the top drowning cases in Florida. The Florida Department of Health also has an asthma prevention program in which Anthony Llau, Epidemiology, was mentioned as the person of reference. Healthy Homes and the Lead Prevention program was also mentioned by The Florida Department of Health's Asit Sarkar as to providing education and deliverables on pool safety and alarms for the underserved.</p> <p>Another objective discussed on the handout was Objective CD1.3.6: serving healthy foods in schools and food kitchens. Charlotte inquired where to gather data for the Measure of Success regarding schools tracking students' body mass index as part of the Healthy Schools Program. Alina mentioned Head Start can be an option for gathering this data.</p> <p>Other recommended Children Issues Committee Objectives were briefly discussed as possible suggestions.</p> <p>Dr. Natale inquired if there were any CHIP objectives for early childhood obesity,</p> | <p>Committee needs to identify which objectives they are capable of pursuing for the next 4 years for the inclusion of the CHIP.</p> |

Charlotte commented that the State Health Improvement Plan did not identify early childhood obesity. | <p>Partner Updates</p> | <p>Asit (FL Health in Miami Dade County)</p> <p>Mentioned FL Asthma Coalition and FL Health in Miami Dade County are partnering together for the Asthma Friendly Childcare centers. Last year 4 bronze certificates were given to 4 daycare centers. This year they are planning to give certificates to 6 daycare centers. The certifications are for being trained on being an asthma friendly center. Asthma friendly child care center trainings will take place consisting of a 1hour training, pre and post tests. They are also looking for elementary schools to become involved as Asthma Friendly elementary schools. There are 6 criterias to get bronze level. | | <p>Joanne (University of Miami) Mentioned they have a program called Project SALT: Self Advocacy Leadership Training that help young adults ages 18-30 or 22-30 with disabilities transition out of the mailman center program teaching them self advocacy skills. Joanne also mentioned FIU has a panther program that helps young adults who finish high school transition to this program. It is 3-4 years where the young adults go to class and have an academic mentor, a job coach and faculty advisor that follows them throughout the 3-4 years ensuring they have job placement.</p> <p>Anthony (Henry Gets Moving) September is Childhood Obesity Awareness Month Suggested for the September 28, 2013 field day event they get sponsors together to make gift bags for kids that can possibly be transferred over to the CHIP initiative. The question Alina brought up is do we want to make this September 2013 field day event part of the work plan and what is its sustainability. Anthony agreed to this notion. He is currently coordinating the field day event. He also welcomed the idea of collaborating with Health Promotion and Disease Prevention committee on the health component for this initiative. Anthony also spoke about the creation of Henry's Hustle- a fun dance activity kids can do that incorporates physical activity. He plans on working with a DJ for music and filming kids doing the Henry Hustle at the September event.</p> <p>Dr. Ruby Natale (University of Miami) A year ago wrote an article based on the CPPW grant (Communities Putting Prevention to Work) regarding child care centers on the needs assessment data and the quality of nutrition and physical activity and family child care homes verses child care centers. | | <p>Natalia Coletti (Healthy Start Coalition) On Saturday, September 7, 2013 there will be a Baby Friendly Summit in Broward county. All of the hospitals in Miami Dade county are invited to participate. This will include educational sessions as well as a panel discussion in which the Healthy Start Coalition will be participating. They will discuss progress done in South FL towards getting these hospitals designated as Baby Friendly hospitals by Baby Friendly USA. This is the 2nd annual summit. They are assisting with promotion in getting a lot of hospitals represented in Miami Dade county. There are currently no Baby Friendly hospitals in Miami Dade County, Monroe or Broward County.</p> <p>Jamie Forrest (FL Asthma Program, DOH) There is a district level award offered for the Florida Coordinated School Partnership and the Florida Action for Healthy kids. At this point about 23 districts have been awarded. Miami Dade has never applied. It focuses on 8 components of the comprehensive school health model.
