Legislative Report	WASHINGTON, D.C., June 26, 2018 —Today, the Senate Appropriations Labor, Health and Human Services, Education and Related Agencies Subcommittee proposed a \$425 million increase for Alzheimer's and dementia research funding at the National Institutes of Health (NIH). If signed into law, Alzheimer's and related dementia research funding at the NIH would reach \$2.3 billion. The hope is to find a cure for Alzheimer's by 2025.

Lambda Living offers programming, counseling, case management and assistance for LGBT persons aged 55 and older.</p>	
<p>Presentation 2: <i>Don't Fall for That! Top scams targeting consumers in 2018 & how to avoid them</i></p>	<p>Bryant Acevedo, Miami-Dade County, Office of Consumer Protection, Dept. of Regulatory & Economic Resources, Business Affairs Division presented on the top consumer scams in 2018 and how to avoid them. The number of scams aimed towards the elderly continue to grow. In Miami-Dade County, the most common scams targeting senior citizens are related to health care. Florida is one of the top states with number of citizens reporting some form of fraud (e.g., scams, cons, schemes, and fakes) to the Federal Trade Commission. Health care scams use television ads, phone calls, and internet ads to get your social security number, financial information, etc. With “You’ve Won!” scams you receive a card, call or email that states you won some sort of prize, but then they tell you there’s a fee, tax or custom duties to pay; they ask for your credit card info, bank info, and/or ask you to wire money or information. Never share financial information with someone who contacts you and claims to need it, and never wire money to anyone who asks you to. Charity fraud prevention tips include:</p> <ul style="list-style-type: none"> ○ Ask as many questions about a donation & research the charity (e.g., call 703-276-0100 or go to Give.org). ○ Never give cash! Contribute by check and make it out to the organization. ○ Request a copy of a charity’s financial report before donating. <p>Guardianship/grandparent/imposter scams are also popular; revolves around family and or “family emergencies.” Imposter scams can come from calls or an email and they claim to be either a government official, grandchild, relative or friend and they request money to pay taxes or fees, or to help someone you care about. No government agency asks you to wire money. Tech Support & Cyber scammers scare consumers into giving their computer control and/or privacy</p>	

	<p>info with threats of computer infections-STOP! Don't click that link! Just HANG UP! Never give control of your computer or credit card info to third party who calls you out of the blue. Do not rely on caller ID alone to authenticate a caller. To get rid of malware, update or download legitimate security software and scan your computer. Delete anything identified as a problem. Report mass marketing/telemarketing fraud complaints to the FTC at www.ftc.gov/complaint. Scammers send unsolicited emails (e.g., from your "bank") asking you to "verify your information" and/or click on a link. Even if the link to "your bank" in the email looks legitimate, you shouldn't click it as it could be a phishing link in disguise. ALWAYS go to your bank's website by entering their address directly into your browser or via a bookmark you made yourself. Never trust links in e-mails, text messages, pop-ups, etc. Without clicking, hover your mouse over the link to help reveal a fake one. The FBI says that "confidence/romance fraud" was the second most reported crime in 2017. An example is someone you met online requests you send or wire them money. Financial Advisor scams include the following: Ponzi scheme, affinity fraud, misrepresentation of credentials. Do not give a financial advisor Power of Attorney or the ability to make trades without first consulting you. Don't act too quickly. Always take time to think about a financial decision. Report cybercrime to FBI's Internet Crime Complaint Center at www.IC3.gov. Locally, the Miami-Dade County Department of Regulatory and Economic Resources' Office of Consumer Protection receives, processes and investigates consumer complaints; call 786-469-2333 or go online www.Consumer@MiamiDade.gov for assistance.
