Approval of	The committee approved the March 2025 meeting minutes with a motion from Nattaliah Earle

Executive	Dr. Cristina Brito, Robert Hill, and Leyanee Perez led the continued discussion with the	
Boarding	Executive Board on the Consortium's role as it relates to upper respiratory illnesses, optimal	
Community Role	health, and factors and conditions that impact health. The following updates were shared	
& Optimal	during this conversation:	
Health Updates	Dr. Brito shared on behalf of West Kendall Baptist Hospital that while colds and flu	
	are circulating, hospitalizations remain slightly down, and no major outbreaks have	
	occurred. West Kendall Baptist has seen a notable increase in detainee patients from	
	Krome Detention Center, rising from 1-2 per month to 4-5 per week, with varied	
	medical issues. Security concerns were noted due to reduced guard coverage, which	
	has been reported to detention leadership. Currently, though system-level discussions	
	are ongoing related to this situation to ensure hospital safety.	
	• Robert Hill shared updates on the <i>Food and Nutrition for All</i> Initiative. He shared	
	that the Food and Nutrition For All appropriation has advanced well in the Florida	
	legislature, with the House recommending full funding—an uncommon outcome.	
	Advocacy efforts continued, and more letters of support are being collected. The	
	initiative's website, foodandnutrition.org , is now live with a new logo, and social

media accounts will launch soon. Two food distribution events are coming up on the 17th and 19th of April, and community presence is encouraged He also noted the sudden loss of NIH funding for a related nutrition initiative, reinforcing the urgent need for collaboration and creative leadership as this work continues without dedicated funding.

• Leyanee Perez provided updates on the food pantry initiative. She shared that food donations from the National Supermarket Association continue, with one Bravo Supermarket in Broward consistently donating to Iglesia Rescate. However, a recent 5,000-poound rice donation had to be discarded due to weevils, likely caused by poor storage conditions. She emphasized the challenge of sustaining donations without dedicated staff to follow up regularly. While the connection was made during the OT21-2103 grant period, ongoing success depends on human effort—like the committed Bravo manager. She hopes future funding will support staff to make those critical reminder calls and prevent wasted resources.

Review Draft Consortium Executive Board Digital Brochure

The Executive Board reviewed the draft digital brochure which includes components of the elevator speech and health agenda message. This tool is being created to help mobilize the Consortium members to be leaders and ambassadors of the Consortium. The Executive Board reviewed and recommended edits to the digital brochure which included the following.

- The Board approved the final English version of the brochure (motion by Leyanee Perez, seconded by Nicole Marriott).
- Pending an update to the QR code, which no longer was active due to the recent website migration to new DOH website hosting platform.
- Once QR code is corrected and the English version receives final approval through the communications workflow, translation will proceed using the state-contracted vendor, Language Line.
- Spanish and Haitian Creole versions will be prioritized to support broader community outreach, including distribution at health fairs and with community partners.

Consortium Annual Event Planning Taskforce Update

The Taskforce for the Annual Consortium Event and worksite Wellness Awards met on April 4th to discuss event planning, including purpose, date, time theme, venue options (e.g., Milander, Vineyard, UM Alumni Center, FIU), and event flow (keynote, panels, breakouts). A full-day event is preferred over splitting into half days for better engagement. The tentative date is September 12, with October 24 as a backup. The team is working on Save-the-Date materials and a vibrant Miami-Vice color theme. Partner outreach is a top priority, with

	members committing to support efforts. Once the package flyer and digital brochure are ready and approved, they'll be used for outreach and introductions. The next meeting will include venue site visits and further logistics discussed.	
Marketing & Membership Updates	For Marketing and Membership, Candice Schottenloher shared that the Consortium website has moved to the state's hosting platform. Updates to the site and directory are in progress. The event calendar is also displaying events through February; past entries are being restored. Members were encouraged to review the website and flag any outdated information or broken features to please send to your Committee Liaison to update.	
DOH Programmatic Updates	Mrs. Adebisi provided DOH programmatic updates on behalf of the Office of Community Health and Planning (OCHP). The Well-being Survey is still open, and several clusters—specifically Clusters 4, 6, 8, 12, and 13 (including Aventura, Miami Beach, Miami Shores, Coral Gables, Key Biscayne, and Downtown Miami)—have not met the minimum response goal. Materials in English, Spanish and Creole will be shared to support outreach. The OT21-2103 CDC grant has ended and is now in the closeout phase; highlights of its impact will be shared. Florida Public Health Week featured state-led themes such as workforce development, personal health, and emergency preparedness. The CHIP meeting originally scheduled for May is being postponed to June and will include voting on new CHIP priorities. Updates will follow.	
Partner Updates	West Kendall Baptist: Cristina Brito shared that Miami Homes for All is seeking community spaces for rental assistance workshops and donations for "welcome home kits" for those moving into housing. A meeting will discuss collaboration and donation logistics, with a potential collection drive at the next Consortium meeting. Housing remains a key priority for the community.	
	Health Promotion Disease Prevention: Leyanee Perez shared that the committee met in person at the Health Council, but attendance was low despite efforts. While virtual meetings may not be as engaging, they tend to have better participation. In-person meetings can be difficult due to logistics. During the meeting, there were presentations on the PACE program and Ryder Trauma Center program.	
	Children's Issues: Candice Schottenloher shared that the committee is finalizing objectives on Alzheimer's awareness through a children's book and training childcare providers on holistic children's health and well-being. They're also aligning their work with observance months. Robert Hill from AHA will present on children's hearth health. The Healthy Baby
