A total of 93 attendees were present at the event, with Tenesha Avent as the Worksite Wellness presenter and panelist on paid family leave and breastfeeding in the workplace. Conversations were made on the update and current funding landscapes on the different executive orders now in place and so making sure that members are updated and aware of funding updates on surrounding programs. any organizations that may be working with or on related initiatives that link community residents to needed services, to reach out to the Taskforce team to help support the work of their partners.

- Dr. Cristina Brito, (Children Issues/ Oral Health Committee Chair) shared that Quest Foundation selected the Food and Nutrition for All Collaborative to be one of their grantees as they move into Miami-Dade County. It was noted the Black Mothers Care Plan with Florida International University (FIU) will be part of this collaborative. The grant will be utilized to address food insecurity in Miami-Dade, and as part of it, will be looking at a mini grant process. More information will be shared going forward into the grant.
- Andrea Hickson, NICU Alumni, shared that every third Wednesday of the month a virtual support group, meets on Zoom that's available to families anywhere to spread awareness. The last support group was hosted on Wednesday, October 15, 2025, with DOH-Miami-Dade WIC and partners from Early Steps. NICU Alumni raises awareness through social media post and emails to the families they support. <u>Virtual Support group Zoom Registration</u>.
- Esther Louis, Metro Mommy Agency, shared ongoing breastfeeding support groups relaunching, for all members of the Community as well as continuing their Breastfeeding Why Black Theories on Saturday October 25, 2025, online. With the funding available, she works on providing direct one on one's virtual maternal health consulting to families coming through their MOMCHA Program to helping them to avoid issues like preeclampsia and hypertensive disorders, so that families can get the support that they need to manage any Chronic conditions as well as preventing any new ones from occurring during pregnancy or postpartum.
- An additional update shared by Esther Louis was on the MOCHA Family Wellness Fair held on September 28, 2025, at KIPP Miami-Dade College North campus. Over 427 registered, 370 attended, 46 partners who supported the event and 32 vendors. They received 9 sponsors and were able to provide free massages to about 100 families, between 4 massage therapists sponsored by Pascal Pediatrics and their Black Moms Miami Group. Thanking The Children's Trust for their support as well as helping to sponsor this event. The MOCHA fair will be hosted again next year 2026 (more details forthcoming).
 - Over the last few months, they have trained 12 doulas to support moms with some more advanced skills to address issues like diabetes, hypertension, preeclampsia, and dehydration. The March of Dimes supported that training and currently at least 40 plus moms have gotten some additional support from those doulas.
 - Also, with support from the CDC Foundation, their DC hot program, which is their doula

Thanks to the funding of the Health Foundation of South Florida, Metro Mommy Agency provides mentorship as well as business development support to the doulas. Members interested are invited to join reducing infant mortality. 	 January 15,2026. Perinatal HIV: Queen Holden shared updates for the Perinatal HIV Program, stating they have had an increase from three moms to seven moms infected with HIV that have agreed to start breastfeeding. Miami-Dade is currently the only program in the State of Florida that has a protocol in place for the moms that attend the clinic over at Jackson. A couple of them now have surpassed the six-month milestone of breastfeeding. They have available a breastfeeding doula that's assigned to these moms, and she's doing a great job to recruit them to give them education and follow up with them. Once they deliver the baby to make sure that the baby is getting to latch, the nutrition, everything the baby needs, and the mom is encouraged to continue until baby wants to release. OCHP: Candice Schottenloher shared an update from the internal CHIP Monitoring and Evaluation (MEC) Committee meeting held on October 16, 2025. The update was related to Congenital Syphilis (CS), the HIV/STD program had shared currently this past quarter we are seeing congenital syphilis cases lower than they were last year. It was noted we are trending in the right direction to reduce congenital syphilis cases in our county.
