Healthy Happens Here sticker	Alina provided a recap of how Healthy Happens Here came about. This is the brand of the Consortium and its initiatives. In particular for the Partnerships to Improve Community Health grant, the Children Issues committee will acknowledge childcare providers by providing intensive technical assistance with some additional recognition. Once childcare providers complete the initial training and improve the quality of services their center provides, they will be recognized as Healthy Happens Here. The center will receive a sticker on their door and certificate. #We Learn Healthy is the tag line. Embracing healthy learning is the function of the facility. Physical activity, nutrition and reducing screen time are what the centers do to make the children healthy. Committee Partner Updates	Silvana Tchorbadjian (Colgate Bright Smiles Bright Future) Colgate is having a Back to School event in September. Colgate will attend a lot of events in 2016. Their calendar is very busy. They have developed a close relationship with Tallahassee and will be visiting there for a children's event in 2016. Colgate also offers oral health education for adults.	
	Stephanie Diez (Reboot & Recover) Reboot and Recover has been working on grant RFPs. They are an innovative 501 non-profit organization that focuses on technology overuse and addiction amongst children and youth. They are in the final process of submitting a research article that was conducted in Florida called <i>Problematic Video Game Playing Amongst Youth</i> . There was a sample of 160 children ages 8-18 in this project. Those dependent on video usage the most were elementary school age males.

Dona Dailey (Community member)

Dona worked with Head Start, teen parents and childcare centers in the past. She also spent some time working in orphanages overseas.

Suecia Mendez (Sunshine Health)

Sunshine Health Plan provides health care for children that have Medicaid. They also have requirements with the state that they have to comply with. Sunshine Health has case management and work with kids that have asthma, diabetes and obesity. They are interested in sponsoring or supporting initiatives throughout the country. They were the signature sponsor for the National Urban League conference that took place in Broward. Sunshine Health was also the signature sponsor for the Federally Qualified Health Clinic conference that took place in Orlando.

Dr. Ruby Natale (University of Miami)

UM is kicking off the USDA grant. 12 intervention childcare centers are receiving nutrition health, physical activity and safety curriculum.

Jeff Hurst (Department of Children and Families)

Child Care Regulations is working on a project in Overtown. They would like to have more centers for youth ages 0-17. Jeff is also working with the Lighthouse for the Blind and ELC with the schoolboard to have an inclusion childcare setting for children ages 0-5. He is also working with MCI on early education. There was a red carpet event at Drew Elementary and Brownsville for kids transitioning from childcare centers to kindergarten for the first time.

Fabio Quintero (Fabimar Harmony)

Fabio is part of the Redland Academy that is a christian school in Homestead. The academy is involved with how to create better communities and environments.

Kristine Perez-Carrion (Flipany)

Flipany will be working with 109 afterschool sites on nutrition education from the Children's Trust. There is a reimbursement with the Department of Health. Through DOH there are 75 sites that they deliver snacks and meals to. Services include access to food and nutrition education. Aug. 28 there is an event called Ten Chefs, Ten Tables at the W hotel. A chef will be cooking table side for all of their participants. On Sept. 14, Flipany's president will be going to the White House to visit Mrs. Obama on the Let's Move initiative.

Karina Pavone (Miami Dade College)

Miami Dade College provide trainings for childcare practitioners. They participated in the Aetna Foundation grant and are currently pursing grants for trainings assisting childcare practitioners in Spanish.

Samantha Sater (Health Council of South Florida)

The PICH evaluation plan was approved by CDC. They will be attending the ELC: Children First conference on Sept. 19 to gather data from the Children Issues committee presentations.

Short Chef (Short Chef)

Short Chef will be attending the Aug. 29th WIC Breastfeeding Walk. He had a cooking demonstration last Friday with Connect Familias for 90 families. Short Chef will also be working with the United Way on Community Cupboard. He will also provide a cooking demonstration for 1000 girl scouts on Oct.3rd.

Focused Fitness does a lot of afterschool work. March 20, 2016 is the National Afterschool Association conference in Orlando where they will be presenting.

City of North Miami will be having a fitness day and are the recipients of the 2015 United States Conference of Mayor's Childhood Obesity grant. With this grant, they are doing free family fitness sessions every first and third Saturday of the month. They are also recipients of the Let's Move grant and will also be joining Flipany in Washington. City of North Miami was also a recipient of the out of school time grant, was recognized on channel 10 and the National Recreation of Parks Association for the nutrition and healthy eating initiative.

Farm Share served over 32 million pounds of food to 4 million families in Florida.
