Work Plan Status Update	Committee Contributions for the Consortium Child Care Initiative were discussed as follows:

	The 5 child care centers being piloted are: Camelot Preschool, Acadekids, Little Big Planet, My Little World, Kiddie Academy Small child care centers were selected as the first choice, due to the need in the south area. Committee will start off with small centers, and later go into the big centers. The Children Issues Committee has come up with the following list of services for one evening a month for 5 months to begin mid-March 2014:	
	Nutrition & Physical Activity- University of Miami team: Dr. Natale, Joanne, Lisa, Maria; Henry Gets Moving: Anthony Rouzier	
	Oral Health- Healthy Matthew: Victor; DentaQuest: Janice; Silvana: Colgate Bright Smiles, Bright Futures	
	Health Fair- Florida Department of Health	
	Technical Assistance- Florida Department of Children and Families.	
	Access to Care- Affordable Care Act- enrolling families into healthcare, eligibility enrollment: Sunshine Health: Nakia	
	A Flyer will be designed for the child care providers with the team going out and schedule. The committee agreed to conduct activities at the centers from 5:15pm-6:30pm. Food will be given to the parents at each of the 5 child care centers. This will consist of a healthy meal to engage the parents. Committee stipend will be used for this purpose. Short Chef and Leyanee Perez, Chair of Health Promotion & Disease Prevention will be responsible for this.	
	An example of what this would look like is Healthy Matthew providing dental	





screenings to the children while the parents are being educated on oral health.	
UM – (Lisa, Dr. Natale, Joanne,)team will be focusing on the Obesity & Prevention component. UM will not need anything from the provider, only space and signs on the door where the presentation will take place. UM will require 30 minutes to set up. Pre & Post Assessment will be designed by Dr. Ruby Natale for the centers. The Health Spark Survey (developed by Dr. Jeff Brosco and Dr. Lee Sanders) will be used to look at multiple domains of health in child care facilities. Maggie- Nemours will be assisting the team.	
Henry Gets Moving—Anthony mentioned he would need space, speakers, and a projector from the providers if they can. He would bring Henry the mascot to engage kids into doing the Henry Hustle dance which will address the physical activity component. Anthony will collaborate with UM to address the physical component at the child care centers.	
The idea is that Lisa & Maggie will focus on educational piece, Dr. Natale & Joanne will focus on pre and post assessment, and Anthony will focus on physical activity.	
Florida Dept. of Health—Health screenings (health fair for families and providers)	
Healthy Matthew —Victor will bring the Healthy Matthew bus at the first child care center visit. At other visits, Victor may bring dental kits, Healthy Matthew mascot, and an educational and nutritional workshop for the families.	
Short Chef—Cooking demonstrations.	
It was suggested that there be a theme at each visited child care center. For example, one school could have a nutrition & physical day, and the other school can have oral health day that the schools can promote. 	The book inspires children to live healthy lives. Teaches kids about the positivity of eating healthy, not eating junk food and playing video games. He is also collaborating with Nemours and Early Learning Coalition action plan. The Motivational Edge Group will partner with Team Henry. They are a non-profit musical program that works with 8-15yr olds helping kids express themselves through music.	
	Jeff (DCF) Mentioned staff will be receiving trainings. He wants to get PSAs for licensing child care homes. Educate the parents on the importance of child care homes being licensed. Want to have some of the provider meetings at UM as well as other universities.	
	Almira Thomas-Gayle (Florida Health in Miami Dade County) Mentioned they are completing BMI and vision screenings at the public schools.	
	Magalie Thomas (Nemours) Mentioned they had their learning session 2 for the child care centers. There was a speaker that spoke on Family Style Dining. They are starting learning session 3 where programs start their piloting acting plan and things they would like to change in their program. A stipend is given and technical assistance provided to help carry out their pilot action plan.	
	Catherina Chang Martinez (Florida International University) Mentioned she is getting ready to defend her proposal on an assessment of best practices in child care centers and at the same time surveying parents. The target population is the latina minority, where there is an increase prevalence of obesity. The idea is to look at the high and low income minority differences when it comes to obesity.	





	Victor Bernal (Healthy Matthew) Is working on a tv show for kids and have a few offers. Would like to have educational videos disseminated to the CI committee. They are currently working with Miami Dade college on a community health fair on February 22, 2014.	Victor will send Shanika a flyer to put on the Consortium website calendar.
	Silvana Tchorbadjian (Colgate Bright Smiles, Bright Futures) Mentioned it is CBSBF second full year in Florida with the dental bus. There are a total of 8 dental buses in the US. This program has been in existence since 1991. In 2012, the company recognized that Florida has a big need for oral health education and prevention as to why they brought the bus here. They visit a lot of schools in Miami Dade and Broward. They also partner with the Jacksonville dental school and travel all over Florida. Walgreens, Walmart, Sedanos, Navarros are also partners. They will also partner with the Early Learning Coalition. CBBF provides education and referral lists for families.
