Welcome and Introductions	The monthly meeting of the Consortium for a Healthier Miami-Dade Children Issues Committee was brought to order by Alfie Leon at 10:03AM. All members were welcomed and introduced themselves.	
Approval of Minutes	There was a motion to approve the November 2014 Children Issues minutes by Short Chef; the motion was seconded by Daniella Orihuela.	
2014 Overview	Child Care Initiative was launched in 2014 where individuals from the Consortium Children Issues committee gathered together to provide technical assistance to child care centers. The area of focus was the South of Miami-Dade. The services provided were: healthy cooking demonstrations, oral health, nutrition, physical activity and access to care. Overall, the pilot was a success and many parents provided great feedback. Child Care providers also provided feedback and were appreciative of the services being rendered at their center. In future months, the committee is looking to continue the Child Care Initiative. The question is the scope, the capacity and applying the skills already learned.	
Committee Partner Updates/projects for 2015	Jeff (DCF)- Child Care Regulations and Family Safety program focus is to educate families and the community. Their initiative is conducting more trainings in the community. Jeff is coordinating with Shanika on the Marketing & Membership committee Speakers Bureau. The focus is to build a team of speakers that will go out into the community to educate on the Consortium and a specific area of expertise. Another goal is to recruit more Marketing & Membership committee members. Sin Wong (All Skills Builders Learning Center)- Certified Behavior Analyst for the	
	Child Welfare program and Psychotherapist for the All Skills Builders Learning Center. They work with kids that have behavioral issues. The center has VPK, daycare and

Short Chef — Mentioned the child care initiative is the best initiative he has participated in. He continues to fight obesity one family at a time. Involved in many camps for the summer. Been offered a position at Common Threads. Has worked with over 1000 kids in the summer. Short Chef has been on the board of Lets Move campaign for 7 years.

Christine & Daniella (FIHI)- works on oral health with children. A lot of unhealthy eating contributes to oral health. FIHI conducted focus groups at the Consortium Child Care Initiative. Thanks to the support of the Consortium, FIHI was able to prove to DentaQuest that consumer engagement efforts were successful. They received a grant due to the Child Care Initiative pilot. They would like to build a large statewide oral health network of stakeholders. This will include policy and grass root levels. The DentaQuest Foundation is adopting a grass root strategy as well. The goal is to connect the community voice with policy makers.

Carla Munoz (FDOH) (WIC)- A registered Dietician who does outreach for the WIC program. Their goal this year is to expand their network and resources in the community. WIC serves pregnant women, infants and children. They provide families with healthy food, nutrition by a Dietician and counseling. Referrals are also provided to the community. The caseload consists of about 72,000 moms, infants and children per month. They participated in the FDOH Breastfeeding Walk, where there were over 300 participants. Short Chef also participated in this event. There are 15 WIC offices in Miami-Dade County. WIC held a fair at their location and the turnout was successful. Over 300 people. Farm Share provided food to the families. Over 400 bags of food was donated to families. This happened a week before Christmas. 200 books were also given to children.





	Marcelle (Amerigroup)- an insurance company that serves Medicaid individuals and Healthy kids. They serve Medicare and long-term care. They have a well-equipped RV to provide free health screenings. They have over 360,000 members and over 12,000 in Miami-Dade. Amerigroup works with food pantries and help with transportation. They are also looking for more partnerships and would like to be a resource center. They service the following areas: Homestead, South Miami, Hialeah, Little Havana, Sweetwater, Little Haiti, Opalocka, Miami Gardens and Liberty City. Marcelle is also involved in a tv show (Island TV) once a month to provide education on Medicaid, Medicare and long-term care.	
	Paloma Lopez Barcena (Early Learning Coalition)- Literacy Week is next week. Ambassadors will read to the children. Parents can participate in Books and Books on January 28 th at 10am. Books can be downloaded from the ELC website. ELC is working on the Children's 1 st Conference held on September 19 th . The theme this year is literacy within the home. Quality Counts will work closely this year on the Monroe community. The TA's are working on the facilities becoming breast friendly. ELC is also focusing on priority programs. These are programs on a low-income census track or serve 30% plus school readiness children.	
	Dr. Ruby Natale (UM)- Mentioned UM received a grant from the USDA on obesity prevention in child care centers. 24 centers for year 1 and 2. 400 centers for year 3.
