Welcome and Introductions	The monthly meeting of the Consortium for a Healthier Miami-Dade Children Issues Committee was brought to order by Alfie Leon at 10:25A.M.	
	All members were welcomed and introduced themselves.	
Approval of Minutes	There was a motion to approve the April 2014 Children Issues minutes by Jeff Hurst; the motion was seconded by Alfie Leon.	
Work Plan Status Update	Consortium Childcare Initiative teams provided updates: Oral Health – Team visited Camelot preschool and had a wonderful experience. This is the first month where all oral health partners were able to go to the childcare visit. Colgate, DentaQuest, Healthy Matthew and the Florida Institute for Health Innovation are the partners. Saw 60 kids and about 30 families. Many parents had more than one child at the center. Colgate provided dental screenings and dental kits for kids. Oral health education was also provided. Healthy Matthew provided stimulating activities for the children, such as song and dance, a giant size toothbrush, staff dressed as huge teeth. DentaQuest provided literature to the parents on milestones of	





gum disease, cavities and myths of fluoride varnish. FIHI collected surveys that build off improvements for oral health in Miami-Dade and Florida. Alfie mentioned he is unable to attend the June childcare center visit and will make arrangements.	
Nutrition Education & Physical Activity- On behalf of Anthony, Dr. Natale mentioned the component was not well attended at Acadekids. Only 3 families attended.	
Access to Care- Jeff mentioned the staff at Kiddy Academy was not aware of the visit and contacted the director. Space was a challenge. From that point on, parents were directed to the childcare initiative. The parents appeared to be in their 20's. Jeff mentioned other centers are inquiring, "What about us?' When are you going to get to us?" "What do we have to do to get our parents involved too?" in the West Kendall, Miller, Sunset, and South Miami area. For future reference, Jeff recommended surveys be given to the childcare centers on those that want to participate in a childcare initiative.	
Dr. Natale agreed with Jeff and added that there need to be a minimum number of participants in order to continue.	
Nutrition/Cooking Demonstration- Shanika mentioned she joined Short Chef at My Little World preschool. Started off with a small crowd, then more parents became involved with the help of the director. The director was very thankful and grateful to receive these services. She also had her children participate with the cooking demonstration. One highlight that took place was a little girl that never ate vegetables decided to eat vegetables after the encouragement from Short Chef.	
Committee Suggestions: -To have by in from the providers. -To have a post survey completed by the parents of what services they are looking for. -To have a packet of materials from all teams disseminated to the childcare centers. This way the childcare centers can continue to disseminate the materials to parents and become an arm for the Consortium. The childcare centers can continue the work of the Consortium Childcare piloting program. The packet can be stamped with, "Brought to you by the Consortium for a Healthier Miami-Dade Children Issues committee."	





	Nutrition Education ~ Catherina visited Little Big Planet preschool. The owner was dynamic and engaged the parents. There was face painting for the kids. 15 families were seen. The sugar shock activity was conducted.

Partner Updates	Shanika mentioned that Team C (Oral Health) component will take place on May 29th at Acadekids at 3:30pm.
	Jeff (DCF) Mentioned a news release that just came out from Tallahassee U.S. Consumer Product Safety Commission is to get parents and affiliates to teach their children how to swim in 2014. And also to take a pool safety pledge. Drownings remain the leading cause of unintentional death for children ages 1-4.
	Alfie (FIU) Mentioned Dr. Rivera, FDOH Miami-Dade Administrator invited him to a new center in Liberty City that FDOH Miami-Dade is opening. They are going to have WIC, Jessie Trice, and the FIU medical college to service special practice needs. Legal services will be available for the community in this center.
	Catherina (FIU) Mentioned she is getting ready to defend her proposal. It consists of using a survey in childcare centers to measure the social determinants in the home environment. What social support do parents have and how they are helping, linking it with the obesity status in children.

New Business	Jackson Memorial Hospital is on the pathway of becoming a Baby Friendly designation. If the individual makes a commitment to go to the event, he/she needs to be there. By the individual not attending, it disables the opportunity for another to attend. Some people that wanted to attend could not, due to the limited space.
