Workgroup/PICH Updates	<p><u>Healthy Happens Here Restaurants:</u> Update provided by Leyanee Perez (American Healthy Weight Alliance):</p> <ul style="list-style-type: none"> – Currently, there are 43 restaurants enrolled for Year 3 of PICH and only 10 more spots are left to meet the goal. – Hyatt located in Biscayne has come onboard with the initiative, the employee cafeteria and its two restaurants will be implementing healthier meals. – Miami-Dade College Culinary school has completed the sensory evaluation. – Schnebly Redland’s Winery has been enrolled in the initiative. <p>Update provided by Maria Negahbani (Florida Department of Health in Miami-Dade County):</p> <ul style="list-style-type: none"> – Puerto Rican restaurant is now enrolled – Isla Del Encanto <p><u>NEMS Reviewer Report:</u> Nicole Marriott (Health Council of South Florida) provided the following update:</p> <ul style="list-style-type: none"> – Customer survey card analysis is still in process. Cuban Guys & Sergio’s are completed. <p><u>Health & Wellness Center (Liberty City Clinic):</u></p> <ul style="list-style-type: none"> – Offers free health screenings and education and provides 3 and 6 months’ follow-ups and one-year follow-ups – The clinic had their first one-year follow-up this month; their numbers had declined. – Green Rx are currently being given out to community members to promote healthier lifestyles. These prescription pads are in Spanish, English and Creole and are able for organizations that are interested in sharing.
