Executive Board Update	The Executive Board update was provided by both Alina Soto and Cristina Brito. As the health agenda is being discussed by the Executive Board, it is important to note that the focus of the Consortium's work should be collective across all committees. Alina Soto and her Co-Chair for Executive Board had visited the Port St. Lucie Health Department. One of Port St. Lucie's initiatives is the Billion Steps Challenge. The Consortium is considering an activity like the Billion Steps Challenge. The Walker Tracker company presented to the Executive Board at the April meeting. The Consortium is trying to partner with Nicklaus Children's Hospital. The cost is higher than anticipated; this initiative would have to target a specific population. It is also important to note from Nicklaus Children's Hospital's Community Needs Assessment some of the indicators of concern included the increased number of fast food family visits and decrease in families eating together. Overall, these are indicators that are being discussed at the Executive Board level that could be considered for the Children Issues workplan.	
	Department of Health (DOH) provided an update on the Community Health Improvement Plan (CHIP) meeting with partners is tentatively going to be in June 2019. At this meeting we will review the Community Health Assessment (CHA) and zero in on the indicators that are important to the Miami-Dade community to create the CHIP which helps guide our work for the next 5 years.	
Healthy Baby Taskforce Update	The Healthy Baby Taskforce is a sub-committee of the Children Issues committee. The Healthy Baby Taskforce focuses primarily on positively influencing the social determinants of health. The overall focus of the Healthy Baby Taskforce includes increasing health education in the community, reducing HIV/STD infections among women of child-bearing age, increasing the percentage of women breastfeeding at six months, and eliminating the racial and ethnic disparities. The online brochure will be voted on today and if approved, it will be posted on the Consortium's webpage. The online resource guide will include resources for working mothers, post-partum mothers, and locations for free-pregnancy testing sites. Lastly, quarterly reporting will be reviewed to make sure indicators are on track.
