	- It was recommended to move Indicator 3.1 under Indicator 4 (Increase health education).	
	- Indicator 3.3 and Indicator 4.4 will be revised to ten social media postings per quarter.	
	This would be a total of forty social media posts for each indicator.	
	- There was discussion on Indicator 3.6 to include healthcare providers to be a part of this	
	indicator. It was noted that there are over twelve birthing facilities and over 300 prenatal	
	care providers in Miami-Dade County. The Taskforce will work with the Healthy Start	
	Coalition of Miami-Dade to come up with a smart goal for this indicator as it is revised.	
	- For Indicator 3.10 it was noted this should be more inclusive of all family members.	
	- Indicator 4.1 there was discussion to include partnering with other organizations to	
	conduct these presentations at existing health fairs and other events to provide tobacco cessation and available resources.	
	- It was discussed among the Taskforce that Indicator 4.5 be removed and combined with	
	Indicator 3.10.	
New Business	- The Taskforce had a brief discussion on the new indicators for the Healthy Baby	
	Taskforce Work Plan which will include a Tobacco cessation and education section.	
	- There was a discussion on how tobacco referrals are obtained, who is screening for	
	tobacco-use and the best way to disseminate this information out to the community.

There will be further discussion on these indicators in the October meeting.</li> <li>A tentative outline for the Breastfeeding Support in the Workplace Policy was shared with the Taskforce members to review. This piece will potentially be included in the Breastfeeding in the Workplace Toolkit which will also be discussed in the October meeting.</li> </ul>	
Partner Updates	<ul> <li>Taskforce members were able to briefly share an update on their current work/initiatives/projects.</li> <li>DOH Perinatal HIV: Queen Holden provided a brief update that for 2018-2019 there are currently zero HIV-positive babies. She also shared one of her staff members was Employee of the Month.</li> <li>WIC: Cheryl Lorie provided a few updates. She shared the success on a WIC event where the peer counselors collected items all year long and presented to the immigrant community in Homestead these items. The second event at FIU there were 25 mothers who received lots of educational material. The unit staff was involved with these efforts and was noted it takes a village for these efforts to come together. Lastly, there is an MOU in process with North Shore Hospital and having peer counselors present in the hospital.</li> <li>Metro Mommy Agency: Esther McCant shared her success on her Breastfeeding with Bae Facebook Live event.
