Approval of Minutes	There was a motion to approve the November 2020 Healthy Baby Taskforce meeting minutes by Candice Schottenloher, the motion was seconded by Leah Jayanetti.	
Previous Action Items HBT Digital Media Campaign	 The Taskforce during the January meeting reviewed the draft of the Healthy Baby Taskforce Social Media Toolkit. This draft document included the recommendations from the November meeting. The contributing partners present during the meeting who provided feedback for the toolkit included: DOH-Miami-Dade HIV Perinatal, DOH-Miami-Dade OCHP, Health Council of South Florida, Healthy Start Coalition of Miami-Dade, ICU Baby, Jessie Trice Community Health Systems, Presently Blooming, Sunshine Health, and the University of Miami. The Taskforce had a consensus and approved the title of the toolkit. The title of the toolkit is <i>Pregnancy and Beyond: A Social Media Toolkit</i>.

	- The team also reviewed the Acknowledgements, About Us section, Mission, Vision, Goals,
	Objectives, Purpose, and each of the theme sections. These sections were updated during the meeting
	with the recommended changes from the members.
	- It was noted that the recommendation to include mother as birthing parent and/ or women of color to
	be more inclusive was included throughout the toolkit.
	- The team shared the <i>Fast Facts</i> infographics to allow the audience to easier capture this data. These
	infographics show both national and local data to better understand the current landscape in the
	maternal and child health field.
	- Other recommendations from this meeting shared by the partners included the following: 1.) Update
	the getting tested link from a local resource to a more national resource. 2.) Review the key terms
	section to include SIDS. Also, to update the terms BIPOC and peer counselor. 3.) Hyperlink the
	second social media posts under the Tobacco Cessation and Education section.
	- There was a discussion among the partners to also include safe sleep, stroller safety, carrier safety as
	it relates to COVID-19, vaccinations and pregnancy, resources for breast pumps, and generational
	family support.
	- The liaison shared she will send the current draft of the toolkit. A deadline was set to have all
	feedback submitted by Friday, January 29, 2021. This feedback will be included in the toolkit and
	shared at the February 2021 meeting for approval to begin to disseminate into the community.
Work Plan	- The Healthy Baby Taskforce Liaison shared the new 2020-2021 Work Plan with the Taskforce. An
	overview of the Taskforce Work Plan was shared with the members. It was highlighted the five focus
	areas of the work plan include:
	1.) Decrease the number of HIV infections
	2.) Reduce STD infection rate.
	3.) Increase breastfeeding.
	4.) Social Determinants of Health
	5.) Tobacco cessation and education.
	- Important updates and changes were highlighted with the partners. These updates included:
	Work plan activities were updated with 2020 baseline and target data.
	The Social Determinants of Health action plan strategy previously was Health Education.
	This update was included to better align with the state's scope of work.
	A total of four new work plan activities have been include in the work plan. These include:
	Increase from 0 (2020) to 1 a focus group consisting of moms, dads, and
	grandparents to identify community beliefs about safe sleep per year.
	grandparents to identify community benefit about safe sleep per year.


