Welcome and Introductions	The April monthly meeting of the Consortium for a Healthier Miami-Dade Children Issues sub-committee (Healthy Baby Taskforce) was brought to order by Esther McCant at 12:32 p.m. All members were welcomed and introduced themselves.	
Approval of Minutes	There was a motion to approve the March 2021 Healthy Baby Taskforce meeting minutes by Heather Baker, the motion was seconded by Esther McCant.	
Previous Action Items HBT Social Media Toolkit	 During the April meeting the Healthy Baby Taskforce announced the <i>Pregnancy and Beyond: A Social Media Toolkit</i> was approved and has included all recommended changes from the March meeting by the Taskforce. The toolkit is now approved and can be disseminated with the community and partners. The Taskforce had a conversation on how they would like to disseminate the toolkit within the community and with its partners. The Co-Chairs of the Healthy Baby Taskforce shared they presented the toolkit previously at the Children Issues Oral Health Committee meeting. It was shared during this meeting at the committee 	



From this outreach the committee can begin to work with this organizations to share the toolkit and have the messaging shared on these pages. It was also noted the dissemination should also be expanded to the community at large and shared with families too. The Healthy Baby Taskforce members agreed with this dissemination process. It was noted the Healthy Baby Taskforce liaison will send a reminder email and compile the social media handles received from partners. It was also shared the Taskforce should leverage both the public and private sector to share the toolkit messaging. Some other opportunities with community partners shared included the World's Greatest Baby Shower's newsletter, presenting to the South Dade Care Coalition, and sharing social media posts with The Children's Trust, JCS, and 311. An announcement was shared thanking the Taskforce members for sharing reporting for Quarter 2 which included the time frame of January 1 – March 31 st , 2021. The report was submitted to the State. The Taskforce had a robust conversation on work plan Activity 4.8. This activity is to increase from 0 (2020) to 1 a focus group consisting of moms, dads, and grandparents to identify community beliefs about safe sleep per year. The Taskforce will begin to focus its efforts on safe sleep and begin to plan the logistics for conducting this focus group in the community. The Taskforce had a brainstorming discussion with its partners on conducting focus groups to identify community beliefs in Miami-Dade County about safe sleep per year. Key highlights from this conversation included: The Healthy Baby Taskforce Liaison shared with the group the overall outcome of the focus group is to hear from the community especially mothers, fathers, grandparents, and providers their beliefs related to safe sleep. We want to have a better understanding what it is that they are learn	
	receiving their information related to safe sleep or not receiving education on safe sleep.	
	Natalia Coletti shared for the target audience for the focus group discussions we should consider	
	the participant's age. This will be important as we begin to develop the focus of the discussions.	



	 The Taskforce will need to develop a strategy to address different age groups. She also highlighted the importance of the intergenerational support element as well as having a strong foundation of understanding while keeping in mind cultural differences too. Other partners shared the importance of trusted sources of where families receive their information related to health and safe sleep practices. The importance of community gatekeepers is important to consider as the focus groups are being developed. It is also important to highlight once the discussions were completed, we would need to provide community resources to support the participants as well as provide an incentive as a solution to safe sleep practices. It was also mentioned these families that participate in these discussions can serve as a support system for one another too. Suecia Mendez suggested for additional information Sunshine Health would be able to provide a presentation on safe sleep to the Taskforce at a future meeting.

	provide. Heather Baker shared the HSCMD provides the ICC curriculum which is focused not only on	
	family planning but also serves as a reproductive life plan that focuses on a variety of topics overall	
	related to women's health. The families that are participating in the longer-term home visiting services through the Healthy Start Program, the pathways, all of them starting in the third trimester of pregnancy,	
	and then once the baby's born. They provide more interconception care than preconception care.	
	Similarly, Suecia Mendez shared Sunshine Health has the Smart Baby Program which helps pregnant	
	women and families but also provides follow-up postpartum conversations related to birth spacing too.	
	It was highlighted from this conversation we should continue to have these conversations and support	
	preconception health through our work.
