	• 12th Annual Breastfeeding Awareness Family Day was hosted on Saturday, August 5 th , 2023,	
	from 10 a.m. to 2 p.m. at Doral Legacy Park Community Center. Around 600 community members attended during the first half of the event. A total count of 90 to 100 mothers	
	breastfeeding simultaneously for the Latch On event were accounted for during this day.	
Safe Sleep Survey Status Update	The Taskforce had the Safe Sleep Survey Status Update updates presented by Candice Schottenloher from	
Presentation	the Office of Community Health and Planning, Florida Department of Health in Miami-Dade County. An update was provided on the status of the <u>Baby Safe Sleep Community Survey</u> the Taskforce designed	
	and launched back in October 2022. Candice Schottenloher shared that during the June meeting there	
	were two polls launched regarding the current survey responses. It was voted by the members to tailor	
	our outreach efforts with not expanding our eligibility window and removing the yes/no question about how I put my baby to sleep. The findings included keeping the eligibility criteria and removing the "is

	intimidate survey respondents on responding "No". Next steps include seeking out further assistance for				
	drafting a letter to have different hospitals help determine where the priority population can be reached				
	and developing social media posts to increase survey responses.				
New Business	The Healthy Baby, Healthy Corner Store initiative that the Taskforce has been working on has been able				
	to accomplish a English, a Spanish and Creole translation for the Palm Card and Business Wallet Card				
Healthy Baby	designs which are intended to be distributed at health fairs and healthy corner stores. We have graciously				
Healthy Corner	been able to work with Rebekah Antoine, Vi Natirèl Family Wellness Institute and Southern Birth Justice				
Store Initiative	Network (SBJN), who provided in-kind services to translate both designs into Creole. There was one edit				
	on behalf of the Office of Community Health and Planning had proposed to the Healthy Retail Committee				
	which was agreed upon to include "TAKE CONTROL of your health and Live Healthy, Miami-Dade				
	County!" Before it was TAKE CONTROL of your health and Live Healthy, Miami Gardens! It was				
	agreed upon as it will expand greater reach in Miami-Dade County at various local corner stores as well				
	as local supermarkets too. The designs are now in the DOH-Miami-Dade Communications approval				
	process. KeTia Harris led a brief discussion regarding the launching process to disseminate out into the				
	community. She also shared the QR code is active and if any updates are needed, to please reach out to				
	her. It was also noted by Leah Jayanetti once approved the digital designs would be great for the NICU				
	families. As more updates become available on the approval, they will be shared with the Taskforce as				
	well as next steps for printing once approved.				
Partner Updates	Taskforce members were able to briefly share an update on their current work/initiatives/projects.				
ranner optaates	- DOH-Miami-Dade WIC: Cheryl Lorie provided updates on waivers. As of August 9, 2023, all				
	prenatal and newly registered babies must initially come in for physical presence and will no longer				
	be certified virtually.				
	- Healthy Start Coalition of Miami-Dade (HSCMD): Ana Maria Rodriguez shared that their				
	Fatherhood State-wide Initiative – $\underline{T.E.A.M. DAD}$ has officially onboarded a Spanish-speaking				
	fatherhood coach. Services can now be provided in English, Spanish, and Creole. The program				
	provides education regarding fathering skills, relationship and communication skills and personal				
	health.				
	- Sunshine Health: Suecia Mendez Padilla shared that mothers' incentives/rewards have been				
	updated. Those who attend 3 prenatal visits will receive \$50.00. And \$20.00 if they attend a postportum follow up visit between 7 to \$4 days. This purpose of this initiative will incentivize and				
	postpartum follow-up visit between 7 to 84 days. This purpose of this initiative will incentivize and				
	increase expecting mothers to attend to their prenatal and postpartum care.
