The Taskforce during this meeting started to further brainstorm and discuss these items noted above in how we would like to focus our efforts on these areas. It was noted we need to consider first what data do we have available from Florida Health Charts and other data sources. Dr. Lebron shared the significance of possibly using data included on birth certificates and what data is included on them. She shared the Florida Vital Statistics Code Manual for Birth resource here that shares more details for the Taskforce to consider. Leah Jayanetti also shared further on some of the recommended topics noted above and possibly looking at them from a lens where we see gaps in the data and is there a correlation that exists. This will need to be further developed by the Taskforce partners.
